CONSENT and RELEASE
JAPANESE BEETLE

I (name) _____ am of legal age and the lawful **owner and/or occupant** of property addressed as (physical address or parcel #) _____ **in Mesa County, Colorado** (the "Subject Property").

The *Popilla Japonica*, also known as the Japanese Beetle ("Japanese Beetle") has been declared to be an invasive pest and public nuisance in Mesa County and must be controlled or eradicated as per C.R.S. § 35-4-101, *et seq.*

I hereby confirm that I have the legal right to authorize Mesa County and any employees, agents or contractors of Mesa County ("Mesa County Pest Control Crew") to assist with removal of the Japanese Beetle by pesticide application in order to control or eradicate the Japanese Beetle which has been located on the Subject Property.

I hereby understand and consent to the following:

- *Entry by Mesa County Pest Control Crew onto the Subject Property for the purpose of removal and/or pesticide application for control or eradication of the Japanese Beetle on the Subject Property.
- * The applied pesticide will be acelepryn, a "reduced risk pesticide" as classified by the EPA, which is considered very safe to humans, pets, pollinators, and birds.
- * Mesa County Pest Control Crew may access the Subject Property at a time and date mutually agreed upon between me or my representative and Mesa County.
- * A follow up treatment application may occur during September. Mesa County will contact me and set up a mutually agreed upon date and time for follow up pesticide application.
- *I will not be charged a fee by Mesa County for the work performed by the Mesa County Pest Control Crew.

In consideration of Mesa County providing assistance, I hereby release Mesa County, its officers, officials, employees, agents, contractors and volunteers, including the Mesa County Pest Control Crew, from all responsibility and/or liability for any damages of any kind whatsoever arising out of the presence and/or work of Mesa County on the Subject Property and/or the application of pesticide on the Subject Property. I agree that I will not bring any legal action against Mesa County, its officers, officials, employees, agents, contractors and volunteers, including the Mesa County Pest Control Crew, for any damages of any kind whatsoever arising out of the presence and/or work on the Subject Property and/or out of the removal or eradication of the Japanese Beetle, including pesticide application on the Subject Property. I agree to indemnify and hold harmless Mesa County, its officers, officials, employees, agents, contractors and volunteers, including the Mesa County Pest Control Crew, for all damages of any kind whatsoever to any person or entity whatsoever arising out of the presence and/or work of the Mesa County Pest Control Crew on the Subject Property and/or out of the removal or eradication of the Japanese Beetle and/or pesticide application on the Subject Property.
